First a girl, then a boy. Then, a second girl and another boy-born within 18 hours of each other.

YOU made sure that CFS was ready to receive a baby whose birth mom chose adoption via Florida's Safe Haven Law. The baby was born drug dependent. The newborn remained in NICU as her little body was weaned off the drugs in her system. Her forever family arrived to be with her, to love her and eventually to take her home. Baby one of 2024!

Then, there was a boy. YOU make sure CFS is available to people caught between two generations-or guide them to other sources for help. Close kin, usually grandparents, contact CFS concerned about how they can become legal guardians for a loved one. CFS staff continued to answer questions from a grandparent until a decision was made, and placement two occurred.

Days continued as usual at CFS. Jerry and Kim met with birth moms, birth dads and adoptive families. I continued to process paperwork and Becky continued to keep the CFS books in order.



At the same time, in another city in Florida, a granddaughter told her grandmother of her unplanned pregnancy. Together, they visited a local pregnancy center. The expectant mom wanted adoption for her unborn child. The pregnancy center suggested speaking with CFS. This mom made an appointment to meet with CFS the following week. However, the baby arrived earlier than expected! The Pregnancy Center adoption specialist kept Jerry and Kim informed about mom's delivery. Jerry and Kim rescheduled their prior commitments of the day and were able to be with this new mom and her extended family to discuss adoption for her newborn.

The same day, a mom Jerry had been working with for several months thought she was in labor. With an earlier pregnancy, she had a quick delivery, so she was concerned that history would repeat itself. She had been turned away by the hospital two times that week (this is not a slight to any hospital; I can't go into further details of pre-childbirth in this account). Jerry was aware the heavily expectant mom was in a lot of pain. He took her to the hospital where, again, she was unable to be admitted. Jerry took her to her home, only to then call an ambulance to pick her up. Her son arrived later that evening and the adoptive family were with mom and child at the hospital.

At the end of that day, Jerry was with the mom and an adoptive family at one hospital while Kim was with the mom who had delivered her child earlier than expected. The new mom, together with her dad and grandmother, reviewed adoptive family profile books with Kim. The following day,









this extended birth family met with the chosen and selected adoptive parents.

A couple days later, Jerry, Kim and I returned to the city where both mom's were waiting to be discharged from their respective hospitals. Two placements, the same day, the same city, but two different hospitals. Placements three and four of 2024.

In these last two placements, birth mothers were able to meet the adoptive parents. This establishes a meaningful connection of family for the child.

YOU made it possible for Jerry and Kim to be available to both women who made adoption plans for their child. YOU gave women Christian Families to choose from to raise their daughter or their son. YOU provided a father to the fatherless. James 1:27. WE thank YOU.


### **2023 FINALIZATIONS**




Chase, Lauren and big Brother Grayson officially welcomed Ensley Gracelynn to their family on 5.9.23.

# MONEY, TEENS. & LIFE

CFS, in an effort to be more proactive, is now sponsoring financial curriculum In two high schools in the city, predominately in East Gainesville (Gainesville HS and Eastside HS). This curriculum has a proven track record of imparting "Foundations in Personal Finance," which leads to better decision making and self- discipline. Following graduation, many students come back and share how they have successfully applied the principles they learned. The sooner young people can learn this the better choices they can make regarding money and debt. Our prayer is that this may also equip them for other aspects of their life involving "counting the cost" and "self-discipline." Many of the clients we work with have never learned these principles and as a ministry, our hope is that it will be one more way to keep many from needing our services in the future. (The curriculum is produced by the Dave Ramsey Education Team.)
